## **BASIS OF DESIGN –** INSTITUTIONAL CHILLER REPLACEMENT CONSTRUCTION MANAGEMENT PROJECT CONSTRUCTION PHASE – DESIGN ENGINEER'S PUNCH LIST

The design engineer shall check off the boxes from the list of company's standardized field observation checklists below that she will need to upload on to her tablet computer prior to heading out to the construction site to complete her final HVAC inspection and punch list. These checklists will be touchscreen type. When the engineer returns to the office or she sends the completed checklists via the internet to the office, the completed checklists shall be automatically downloaded to the company's computer server and placed in the job folder's "Project Closeout" section of the folder. The completed checklists, along with associated digital photographs taken at the time of the field visit, will automatically be electronically sent to the following individuals and departments.
